Pioneer Electric is offering a bill credit to cooperative members who purchase and have professionally installed attic insulation in their homes in 2023. This incentive is only available to residential home owners. Members must have the insulation installed by a licensed contractor by December 31, 2023.



To earn a **\$200 bill credit** members must have the insulation installed by a licensed contractor. Only one incentive is permitted per residence.

#### Additional qualifications:

- All projects must be a retrofit installation in an existing residential home on Pioneer lines. Program is not applicable to new construction, room/home additions or expansions, or commercial.
- Contractor must follow **ENERGY STAR**® guidelines and achieve minimum R-42 for the attic.
- All applications must be complete and include an itemized contractor invoice.
- All projects must comply with applicable federal, state, and local laws and building codes.
